### Information about Yavapai Recreation League (YRL)

YRL is a shooting organization, which recognizes and practices many different shooting disciplines.

YRL has purchased 20 acres of land for what promises to be a first class shooting facility. This property is located 12.7 miles south of Highway 89 from the White Spar Safeway if you are coming from Prescott. It is approximately 2 miles north of Wilhoit if you are coming from the Valley. Turn on Forest Service Road 71.

We have matches in the following disciplines:

- USPSA
- Steel Challenge
- IDPA
- Cowboy Action Shooting
- ICORE
- Metallic Silhouette (22 rifle or pistol)

YRL is not limited to shooting these disciplines. As the need and the interest of the members dictate, others may be added from time to time.

Other programs include Youth Oriented shooting and Safety Education, Range Rental for Shooting Schools and opening the facilities to Local Law Enforcement Agencies.

### Explanation of Memberships

***All New Members are required to participate in a “New Member Orientation”. An authorized Board Member must conduct the Orientation. This orientation helps a new club member to understand current Range Rules and operations of the YRL. A new member may be checked for firearms handling and safety skills during the orientation.***

**1. Annual Basic Membership:**

- a. This standard annual membership expires on March 31<sup>st</sup>.
- b. Range access for practice is **NOT** included with this Membership.
- c. Benefits include but are not limited to a reduction in regular match fees.
- d. This annual membership includes immediate family members. Note: All members must be identified at the time of the application; new family members may be added at the time of renewal in subsequent years.
- e. The primary member is the only voting member and “owner” of the membership.
- f. An immediate family member is defined as a spouse (or significant other) of the primary member or a person under the age of 21 of whom the primary member is the legal guardian.

**2. Annual Range Access Membership:**

- a. This membership includes all of the benefits of the Annual Basic Membership plus:
- b. Access to the range for the purpose of practicing. Restrictions apply, see the web page.
- c. The member is encouraged to bring a guest when he/she practices. The member **MUST** be present when guests are on the range practicing.
- d. A guest book is provided and must be signed by the membership owner and all guest(s).

**3. Lifetime Range Membership:**

- a. Includes the benefits of an Annual Range Membership for the life of the member at a one-time cost.

- b. Life Members will pay member rate event fees.

## Membership Application Pro-rated Fee Schedule

Dues are pro-rated on a quarterly schedule as listed below.

Jul/Aug/Sep	\$37.50 + Initiation = \$62.50	\$ 75.00 + Initiation = \$100.00
Oct/Nov/Dec	\$25.00 + Initiation = \$50.00	\$ 50.00 + Initiation = \$ 75.00
** Jan/Feb/Mar	\$62.50 + Initiation = \$87.50	\$ 25.00 + Initiation = \$150.00

\*\* If you join as a new club member in *Jan/Feb/Mar* you will be paying the pro-rated dues for membership plus the following years annual dues.

Initiation Fee is \$25.00 for all new members.
