## Yavapai Recreation League

### RANGE RENTAL AGREEMENT

By signing this agreement, I and the organization I represent, Agree to abide by the rules and regulations of the Yavapai Recreation League shooting facility.

1. We understand that the prime priority of YRL is SAFETY, and agree to conduct our events with the highest standards for our participants and for others.
2. We will provide trained safety officers to supervise our events.
3. We will be responsible for our participants and spectators, for range safety, range conditions and cleanliness.
4. We understand that this agreement does not eliminate our liability should an incident occur.
5. We understand that we are responsible for set up and cleanup.
6. We agree to set up our courses of fire so as not to damage any trees in the vicinity or in the bays.
7. Sufficient temporary toilets will be provided by YRL in the case of large numbers.
8. We understand that there is an advanced scheduling procedure and that all reservations and cancellations must be made in writing. We also understand that reservations cannot be made if fees are unpaid.
9. We understand that there is a deposit fee of \$250.00 due no less than 10 working days prior to the use of the YRL facility. This deposit will be applied toward the overall payment unless YRL determines that the facility was left in an unsatisfactory condition, at which point it will be applied toward clean up, and/or repair.
10. We agree to pay YRL all application fees within ten working days after each event. The fees for using the YRL range will be \$15.00 per person per day, \$50.00 per day per bay, \$50 per day for the classroom, and \$100 per day for the use of the rifle ranges.
11. We understand that we must carry our own liability insurance to cover our activities at the YRL shooting facility, and that the Yavapai Recreation League Corporation will be named in said policy as additional insured. A current copy of the certificate will be provided to YRL and kept filed with this agreement. A lapse of insurance coverage nullifies this agreement.
12. We understand the non-compliance with this agreement, rules, procedures and instructions from the Range Master, safety violations, or late payment of fees will result in loss of privileges to use the YRL facility.
13. Calendar dates reserved on a "first come first served" basis after deposit.
14. The dates you requested will be reserved when deposit is received.
15. You will receive a receipt of this form by email.
16. Cancellations: Up to 15 days before scheduled event, 100% refund. After that a \$25.00 Fee will be retained because of time and effort put into scheduling and preparation for your event.
17. Special Range Fees: Groups that rent the range on a regular basis are allowed a customized range use fee. Please contact the YRL management for more details.
